## A MESSAGE FROM DOUG NEALEIGH

As we communicated earlier this week, a fire occurred at the Inn this past Sunday morning at approximately 1:30 AM. The fire originated in the Maintenance Area in the basement of Building Four. Emergency services responded immediately to the alarm. No one was injured and Building Four was successfully evacuated. VVA staff has been onsite daily working with our onsite team managing the many tasks associated with getting the building back on line as quickly as possible.

Local and State Fire Inspectors have been on site. We were in immediate contact with our insurance broker as well as the claims representative from Zurich Insurance. We've communicated with their local Field Representative who plans to be at the property later this week. Two mitigation companies were at the property on Wednesday to inspect the



areas and provide estimates for repairs. The selected company should be able to have their team onsite by the end of the week to begin the

required repairs and cleaning to get the units back into inventory.

As noted earlier, aside from smoke there was little damage to the units in Building Four, with the exception of doors and sheet rock which were impacted by the fire fighters gaining access to the rooms. However, the maintenance area sustained significant damage to the interior structure including the loss of equipment, tools, and supplies – all of which are insurable. We will continue to provide updates as we work through the process of bringing the units back into inventory and processing the many details associated with this unfortunate event.

As a reminder, losing 25% of our inventory moving into the holidays creates challenges for us to accommodate existing reservations. For those of you who currently have reservations over the Christmas and New Years holiday, if you're in a position to postpone those plans, it will allow us to minimize the cancellations for some Guests. Please call the property to confirm and/or cancel any reservations you might have over the next several weeks. We greatly appreciate your understanding and cooperation during this difficult time.
